Government Affairs

Montgomery County

- Thanks to **spirited member testimony** and **3k+ emails** to councilmembers, stopped property & income-tax increases
- Endorsed City of **Gaithersburg Mayor Jud Ashman** (first time GCAAR has gotten involved in a municipal race)
- Hosted Councilmember Dawn Luedtke to preview the 2026 budget cycle
- **100+ members** attended Legislative Breakfast to meet with local, state and federal leaders



Testified on various issues, such as stopping proposed tax increases and in support of More Housing N.O.W.

District of Columbia

- Extended the deadline for the new **RentRegistry** **from 90 to 180 days**. Also hosted event to educate housing providers on how to navigate the system
- Hosted Councilmember Robert C. White to discuss modernizing the **Home Purchase Assistance Program**
- Supported 2-4 unit exemption to the **Tenant Opportunity to Purchase Act (TOPA)** & worked to correct language that would have put existing single-family exemption in jeopardy
- Pushed legislation to encourage new housing and provide more flexibility for housing providers to grow
